### 2. HAZARDS IDENTIFICATIONS

#### Potential Health Effects

**Primary Routes of Exposure:** Routes of entry for solids and liquids include eye and skin contact, ingestion and inhalation. Routes of entry for gases include inhalation and eye contact. Skin contact may be a route of entry for liquefied gases.

**Acute Toxicity:** Relatively nontoxic after single ingestion. Relatively toxic after short-term skin contact.

### 4. FIRST AID MEASURES

**General Advice:** First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. **If Inhaled:** Remove the affected individual into fresh air and keep the person calm.

**If on Skin:** Rinse skin immediately with plenty of water for 15 - 20 minutes.

**If in Eyes:** Hold eyes open and rinse slowly and gently with water for 15 - 20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing.

**If Swallowed:** Never induce vomiting or give anything by mouth if the victim is unconscious or having convulsions. Do not induce vomiting. Have person sip a glass of water if able to swallow.

hydrocarbons. If product is heated above decomposition temperature, toxic vapors will be released. The substances/groups of substances mentioned can be released if the product is involved in a fire.

**Further Information:** Evacuate area of all unnecessary personnel. Contain contaminated water/firefighting water. Do not allow to enter drains or waterways.

### 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions:** Take appropriate protective measures. Clear area. Shut off source of spill only under safe conditions. Extinguish sources of ignition nearby and downwind. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment.

**Environmental Precautions:** Do not discharge into the subsoil/soil. Do not discharge into drains/surface waters/ groundwater. Contain contaminated water/firefighting water.

**Cleanup:** Spilled substance/product should be recovered and applied according to label rates whenever possible. If application of spilled substance/product is not possible, then spills should be contained, solidified, and placed in suitable containers for disposal. After decontamination, spill area can be washed with water. Collect wash water for approved disposal.

### 7. HANDLING AND STORAGE

#### Handling Information

**General Advice:** *Recommendations Are For Manufacturing, Commercial Blending, And Packaging Workers.*

Pesticide applicators & workers must refer to the Product Label and Directions for Use attached to the product for Agricultural Use Requirements in accordance with the EPA Worker Protection Standard 40 CFR part 170.

- Ensure adequate ventilation. Provide good ventilation of working area (local exhaust ventilation if necessary).
- Keep away from sources of ignition. No smoking.
- Keep container tightly sealed.
- Protect contents from the effects of light. Protect against heat. Protect from air.
- Handle and open container with care. Do not open until ready to use. Once container is opened, content should be used as soon as possible.

- Avoid aerosol formation. Avoid dust formation.
- Provide means for controlling spills.
- Do not return residues to the storage containers.
- Follow label warnings even after container is emptied. The substance/product may be handled only by appropriately trained personnel.

### Personal Protective Equipment

#### **RECOMMENDATIONS FOR MANUFACTURING, COMMERCIAL BLENDING, AND PACKAGING WORKERS**

**Respiratory Protection:** Wear respiratory protection if ventilation is inadequate. Wear a NIOSH-certified (or equivalent) organic vapor/particulate respirator. For situations where the airborne concentrations may exceed the level for which an air purifying respirator is effective, or where the levels are unknown or Immediately Dangerous to Life or Health (IDLH), use NIOSH-certified full facemask pressure demand self-contained breathing apparatus (SCBA) or a full facemask pressure demand supplied-air respirator (SAR) with escape provisions.

### 11. TOXICOLOGICAL INFORMATION

#### Acute Toxicity

**Oral (LD<sub>50</sub>, rat):** >5,000 mg/kg [No mortality was observed.]

**Dermal (LD<sub>50</sub>, rat – male/female):** >5,050 mg/kg [No mortality was observed.]

#### Irritation/Corrosion

**Skin (rabbit):** Non-irritant

**Eye (rabbit):** Mildly irritating

**Sensitization (guinea pig):** Non-sensitizing

The below information is on the active ingredient, imazamox.

**Genetic Toxicity:** No mutagenic effect was found in various tests with microorganisms and mammals.

**Carcinogenicity:** In long-term studies in rats and mice in which the substance was given by feed, a carcinogenic effect was not observed.

**Reproductive toxicity:** The results of animal studies gave no indication of a fertility impairing effect.

**Development:** No indications of a developmental toxic/teratogenic effect were seen in animal studies.

### 12. ENVIRONMENTAL INFORMATION

The below information is on the active ingredient, imazamox.

**Assessment of Aquatic Toxicity:** There is a high probability that the product is not acutely harmful to fish/aquatic invertebrates. Very toxic (acute effect) to aquatic plants.

**Fish Acute LC<sub>50</sub> (96 hr):** *Oncorhynchus mykiss* ≥122 ppm

**Aquatic Invertebrate Acute EC<sub>50</sub>:** *Daphnia magna* >122 ppm

**Aquatic Plant EC<sub>50</sub> (120 hr):** Algae >0.037 mg/l

**Assessment of Terrestrial Toxicity:** With high probability not acutely harmful to terrestrial organisms.

#### Other Terrestrial Non-Mammals:

**Mallard duck LC<sub>50</sub>:** >5,572 ppm

**Honey bee LD<sub>50</sub>:** >100 ug/bee

**Degradability/Persistence/Biological/Abiological Degradation:** Not readily biodegradable (by OECD criteria).
